## Honorable City Councilors:

I respectfully submit this docket item to your Honorable Council requesting the authorization to appropriate and expend an additional \$10 million of bonded indebtedness to fully fund a new building for the Newton Center for Active Living Project (NewCAL) which will have a total project cost of \$30.5 million.

This morning we opened the bids for the NewCAL project for the second time with a \$7.5 million reduction in total costs from September 2023. Given the significant inflationary pressures in the building industry that we had anticipated and planned for, we expected bids that resulted in a total project cost greater than the previous amounts found in the CIP. The low bid results in a total project cost of \$30.5 million.

With rising construction costs, we have been adjusting our debt service assumptions in the Long-Range Financial Plan to allow for this critical project to move forward. As a reminder, City Council approved early this month the Lincoln-Eliot School project which also experienced construction cost increases.

We began contemplating a new senior center in 2018. After five years of hard work with well over 1,000 residents contributing to this project, we are excited to move forward with this transformative building. NewCAL will meet the needs of Newton's older adults for generations to come while also serving the broader Newton community.

This \$30.5 million project complements nearly \$250 million in school facility investments underway at Lincoln-Eliot, Countryside, Franklin, Horace-Mann and completed projects for students and teachers at Oak Hill Middle School and the Newton Early Childhood Program (NECP), among others.

Attached is a memo from Public Buildings Commissioner Morse requesting the docket item.
