No Parking Tow Zone: Monday April 21, 2025 from 12:00am until 7:00pm.

Washington St: From the Wellesley Line to Auburn St

Commonwealth Ave: From Auburn St to the Boston Line

All Feeder Streets Along Race Route: Within **60 FT** of the Route and on the Fire Hydrant side of the Street.

Algonquin Rd even side (New)

Beacon St: From Washington St to Dorset Rd;

Beacon St Extension (North of Washington St)

Centre St: From Homer St to Ward St

Chestnut St: From Beacon St to Highland St

College Rd: From Beacon St to Commonwealth Ave

Concord St: From Hagar to Washington St

Dorset Rd: From 1947 Beacon St to 215 Dorset Rd

Evelyn Rd: From 192 Evelyn Rd to Fuller St; From Paulson Rd to MaryEllen Rd (New)

Evelyn Rd: From Beacon St to Paulson Rd (Odd Side) (New)

Fuller St: From Day St to Evelyn Rd

Grant Ave: From Montvale Rd to Ward St

Grove St: From Washington St to Woodland Rd

Hammond St: From Ward to Beacon St
Homer St: From Commonwealth Ave to Centre St
Lowell Ave: From Commonwealth Ave to Hull St
Maple St: From Woodland Rd to **Auburn St (New)**
Old Colony Rd: From Priscilla to Commonwealth Ave
Quinobequin Rd: From I 95 Southbound ramp to Washington St
Waban Hill Rd even side **(New)**
Walnut St: From Homer St to Mill St
Ward St: From Centre St to Manet Rd
Woodchester Dr: even side Algonquin Rd-Woodlawn Dr **(New)**
Woodland Rd: From Grove St to Washington St

Road Closed: Effective Monday April 21, 2025 from 08:00am until 7:00pm.
